### Current research interests

My current research project is on the history of capitalism viewed through the practices of accounting. Basically, I am working on the investment strategies and refinancing of companies and “private” investors in mid-sixteenth century Europe. The referring key issue are the configuration and the dynamics of financial markets and the response to crises, when the Crowns failed to repay the enormous loans they had taken. Hence, the knowledge of accounting became the essential feature to get along with the highly diversified instruments of return and to adapt to ongoing economic processes. At the core of my argument is a complex comparison between Florentine and South German enterprises and private investors that I call *Capitalist Rentiers*. Particularly, the focus is on the secondary markets which supported government finance on the one hand, and on intercultural transfers and the impact on consumption on the other.

My evidence is mainly preserved in the Salviati archives in Pisa and the Apostolic Library of the Vatican, in the *Archivio di Stato di Firenze*, in other familial archives in Tuscany and in South German Archives.

Moreover, I am specialised in the history of accounting from the late thirteenth century on (account books, letters, ricordanze, diaries) which I am putting in a broader social and cultural context. The accumulation of wealth in the hands of households and parental lineages is an issue of particular interest. The history of accounting makes part of the histories of writing, technology and knowledge. Further on, I studied institutional accounting for the development of the fiscal systems of states in the fifteenth to the eighteenth centuries.

I have been working on government finance, the coming of statistics and bureaucracy, animal history, European diplomacy, military history, and art history.

### Teaching competences

In general, I have been teaching various topics of Early Modern Europe for seventeen years, now. My courses are on European history from the Middle Ages to the 21<sup>st</sup> century, on the Mediterranean, on state building and the fiscal state, on military and diplomatic history, on animals in history, on the history of cities, on social history like the history of witchcraft, on history of communication, and European Enlightenment.

In the last years, I concentrated my teaching on social and economic history like introduction courses on Medieval economic history, and the history of capitalism, and specialisation courses in the history of markets, Italian city states, families and wealth.
